Summary of Facts:

Plaintiff Reliable Capital LLC, owned by Curt Potts, said it executed a finders fee arrangement with Eagle Valley Ventures (EVV), an unincorporated arm of the Tonto Apache Tribe, in April 2019. The purpose of the arrangement allegedly was for the plaintiff to secure a relationship between EVV and defendant Tech Processing and Servicing Inc. Amy Potts, Curt's wife, reportedly was the defendant's director, president, secretary, and treasurer.

The plaintiff said that per the arrangement, if EVV entered into an agreement with the defendant, EVV was to pay it a percentage of the revenues EVV received from the agreement. The arrangement reportedly did not have a termination clause.

The plaintiff said it secured the relationship, EVV entered into an agreement with the defendant, and EVV began making making payments to it per the arrangement.

Curt and Amy divorced, with the divorce being finalized in May 2020. The plaintiff said the divorce was contentious.

After the divorce, Amy reportedly told EVV that she thought Curt's deals were a scam. The plaintiff said the defendant told EVV to cut ties with the plaintiff, and Amy made recommendations as to how the Tribe could terminate the relationship with the plaintiff.

In July 2020, EVV reportedly terminated the arrangement.

The plaintiff asserted tortious interference with contract.

The defendant claimed the termination of the arrangement was an internal decision of the Tribe. It also contended the arrangement was invalid since the Tribal Council failed to ratify or approve it.
